Christ for a Continent: Through Christ for a Continent, FRM continues to equip indigenous leaders to advance the Gospel across Africa. In South Sudan, chaplains serve on the front lines—bringing hope, discipling soldiers, and ministering to families amid conflict. In Nigeria and the DRC, trained missionaries are being sent into unreached regions to plant churches and stand for Christ in areas of persecution. In Uganda and Kenya, ongoing church planting and pastoral training strengthen local congregations, while FRM-supported primary and secondary schools in Uganda provide children with both quality education and a foundation in faith. From the battlefield to the classroom, the Gospel is transforming lives and shaping the future of a continent.

Ghost Operations: Across some of the world's most dangerous regions, Far Reaching Ministries continues to stand with those risking their lives to bring hope and relief. Through Ghost Operations, FRM supports chaplains, pastors, and frontline workers serving amid war, persecution, and crisis.

a. Ukraine: FRM's chaplains remain active on the front lines—evacuating civilians, delivering aid, and sharing the Gospel amid the war. Over 60 leaders were renewed through a chaplains' retreat, and 27 new chaplains sponsorship program. Construction continues on a major training and rehabilitation center for children and a larger home for the elderly. In addition to this, FRM provided 1,500 winter jackets for children, and supported monthly church feasts, Christmas outreaches, and the ongoing "Potatoes for Grandmothers" program—meeting both physical and spiritual needs across Ukraine.

b. Syria: FRM provide monthly support for the basic necessities to rescue Druze seeking sanctuary from the genocide. We are hoping to provide medical services for the most vulnerable through financial support to local hospitals where staff have been working with no salary for most of 2025.

c. Georgia and Moldova: FRM sponsored Christmas outreaches, aid for refugee and elderly families, and pastors' conferences for displaced Russian ministers, with additional retreats planned for 2025 & 2026. More than 450 underground pastors across Eastern Europe and Asia continue to receive vital support, ensuring persecuted believers can survive and minister in secret.
