Missionary Outreach: We disciple women of faith using the Bible as our textbook. Our key initiatives for 2024 included weekly discipleship classes of our staff trainers and then ongoing classes in multiple communities in South Sudan. In 2024 we offered eight different classes per week, each group translates the material into the local dialect and all attendees are able to ask questions and share testimonies. Groups are no larger than fifty women each and weekly sessions last approximately two hours. The project director also teaches women in church retreats in the United States. We invest in pastors' wives, Chaplains wives, and teachers of other women or children from Russia, Ukraine, South America, Mexico, and other African nations.

Aviation: Far Reaching Ministries Aviation (FRMA) continues to serve as a vital lifeline across Africa through its partnership with Mission Aviation Fellowship Uganda (MAF). This collaboration allows missionaries, chaplains, and relief teams to reach regions inaccessible by road-delivering supplies, personnel, and emergency aid to the front lines of ministry. FRMA flights support discipleship programs, chaplain training, and humanitarian outreach, ensuring that the Gospel and the help it brings can reach even the hardest and most remote places.

Rabuna Fi: In 2024, Rabuna Fi "God is able" continued to disciple and equip women across South Sudan through daily teaching and weekly Bible studies. Seven active groups now meet in Nimule and surrounding communities, including Calvary Chapel Nimule, Rei Community, Motoyo West Anglican, Rock City Fellowship, and several gatherings among newly displaced families from the Murele tribes. Three women trained through Rabuna Fi were ordained as pastors through the Anglican Church of South Sudan and now lead outreach within the Mother's Union network. Two additional women have begun teaching in nearby IDP camps, multiplying the ministry's reach. Even in the teacher's absence, locally trained leaders continue weekly studies, prayer gatherings, and literacy classes - demonstrating that God truly is able to sustain and grow His work through faithful women.

All senior management personnel flying across the USA or international are eligible for first, business or premium economy seats. Each staff is required to clear with the CEO if cost per seat is 50% higher. CEO is authorized to approve or deny all requests.

Travel for board of directors spouses is allowed when an annual meeting or retreat is being held. If the spouse requests to attend and volunteers to serve when staff is speaking to fundraise, that is allowed, provided audience size is great enough to warrant extra help. Those expenses for travel are shown in Fundraising class.

Housing allowance is available only for ordained pastoral staff. FRMA currently has NO pastoral staff or housing allowance.

FRMA has a handbook with corporate policies and procedures. We developed a procedure for requests for reimbursement and outline what type of receipts are accepted by the IRS, for travel expense reimbursement. In addition, any employee with a corporate credit card is required to provide written backup for every charge in accordance with IRS requirements.
